# Instructions for the differentiated collection of waste



# PLASTIC PACKAGING



Use the **Yellow** container/bag assigned to your user

*The **fundamental rule** for the correct collection of plastic is to **recycle only packaging materials**. Packaging includes containers, wrappers, bottles and cases that contain, wrap and protect the things we buy.*

## EXAMPLES OF PLASTIC

- **Disposable plastic dishes and cups** provided that they are properly cleaned and free from organic material
- Bottles for water, soft drinks, oil, juices, milk, etc.
- Tea bricks, bottles of detergents, soaps, various products
- Tubes for creams, sauces, syrups, straws, etc.
- Hard packs for plastic or polystyrene desserts, transparent boxes, rigid/flexible packs for foods in general (*cold cuts, cheeses, fresh pasta, etc.*)
- Food trays (*eggs, ice cream, etc.*)
- Containers for yoghurt, cream cheese, desserts
- Netting for fruit and vegetables
- Containers for the packaging of various products (*cosmetics, wet wipes*)
- Pots for plants (maximum diameter 15/20 cm)
- Envelopes and bags for food in general (*pasta, rice, potato crisps, sweets, snacks, etc.*)
- Sacks, bags, envelopes in general (shopping)
- Small plastic from packaging (*bottles, toilet paper packaging, etc.*)
- Polystyrene (if large, reduce the size)



### **Remove food residues!**

Plastic should not be washed, but in the case of very dirty packaging/containers, it is advisable to simply rinse them and make sure that there are no food residues that could cause unpleasant odours.



**Crush plastic bottles** and screw the cap on to **reduce their volume**

## Some of the most common mistakes to avoid:

### **NO Toys**



Dispose of toys with no electronic parts in the containers for **Dry Residue Waste**

### **NO Tetra Pak**



Dispose of it in the container for **Paper and Cardboard**

### **NO Pads**



Dispose of them in the container for **Dry Residue Waste**

### **NO Disposable cutlery**



Dispose of it in the container for **Dry Residue Waste**

### **NO Stationery**



Dispose of it in the container for **Dry Residue Waste**

### **NO Electronics**



Take them to the **Recycling Centre**

### **The fundamental rule:**

***"Is it only packaging that is separated?"***

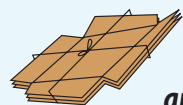
If you are unsure, remember that by law **only plastic packaging** can be separated; that is, those objects expressly designed to contain, protect and transport goods.

# PAPER AND CARDBOARD



Use the **Blue container** assigned to your user

- **Tetra Pak** (cartons for milk, fruit juices...)
- Newspapers and magazines
- Brochures and flyers
- Old exercise books
- Paper bags
- Cardboard packaging and boxes
- Pizza boxes (if not too dirty)
- Paper tablecloths
- Scratchcards



**Break up  
any boxes!**

**Crush and fold any  
cardboard boxes to  
reduce their volume.**



**Plastic bags are not paper!**

If you collect paper in plastic bags, empty the contents into the Blue container and dispose of the bag in the container for plastic waste.

# GLASS



Use the **Roadside Dome Bin**

- Bottles, flasks, and glass jars  
(remove the steel and aluminium covers)

# TIN AND ALUMINIUM



## Households:

Take them to the recycling centre

## Catering (HO.RE.CA.):

Use the container assigned to your business

- Food boxes and cans (tuna, meat, vegetables, pet food, etc...)
- Aluminium cans
- Empty paint cans
- Steel or aluminium caps or covers
- Aluminium food trays (relatively clean)
- Aluminium tubes (mayonnaise, creams, etc.)
- Nails, screws, wire and small pieces of metal from household maintenance



## REMOVE FOOD RESIDUES!

The cans should not be washed, but it is a good practice to simply rinse them to make sure that there is no residue of food or liquids.

# DRY RESIDUE WASTE



Use the **Grey** container assigned to your user



***Dry Residue Waste does not mean that you can mix the waste and avoid sorting it!***

As for example:

- **Nappies, pads and bed-wetting pads**
- **Sanitary towels**
- **Plastic cutlery**
- Disposable masks and gloves
- Rubber and plastic toys
- Coffee capsules made of hard plastic
- CDs, DVDs, music cassettes and video cassettes
- Objects in ceramics, porcelain, Pyrex glass and glass-ceramic
- Dust from vacuum cleaners or house rubbish
- X-rays, photographic films and slides
- Incandescent lamps
- Pens, felt pens and stationery in general
- Toothbrushes and sponges
- Greaseproof paper, plasticised and thermal paper (receipts, faxes, etc.)
- Baking paper, dirty paper and wet wipes
- Tights and stockings
- Cigarette butts (*extinguished*)
- Carpets, cloths, fabrics and clothing that is no longer used
- Irrigation pipes
- Mirrors and crystal
- Cups made of glass

### NO Organic Waste



Dispose of it in the container for **Organic Waste**

### NO Plastic



Recyclable plastic should be disposed of in the containers for **Plastic**

### NO Paper and Cardboard



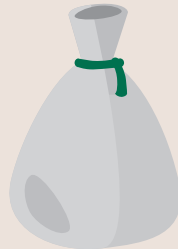
Recyclable paper should be thrown into the containers for **Paper and Cardboard**

# ORGANIC WASTE



Use the **Brown** container assigned to your user

- Fruit and vegetables waste
- Unpacked spoiled food
- Meat and fish in small pieces
- Dairy products
- Egg shells
- Grounds of tea and coffee or of other infusion drinks
- Paper napkins or tissues
- **Sawdust and wood ash**  
(with no embers and packaged)
- Absorbent kitchen roll  
(damp or oily)
- Leaves and soil
- Animal excrement



## ***Close the bag well!***

Dispose of waste after having correctly placed it in Biodegradable and/or Compostable bags.

## **NO pads**



Dispose of them in the container for **Dry Residue Waste**

## **NO Plastic Bags**



Dispose of **Organic Waste** inside Biodegradable bags avoiding the use of plastic bags



## **DOMESTIC COMPOSTING**

Composter | 300 L

Usable by anyone with at least 150 sqm of land (gardens, orchards, etc.)

## **The following waste should be disposed of in the Composter:**

- Kitchen waste, leftovers, spoiled food (remove from the packages)
- Fruit and vegetable waste (including the woody parts, e.g. dry fruit)
- Coffee grounds and tea and chamomile filters
- Cut flowers, wilted plants, leaves and grass cuttings
- Stale or mouldy bread
- Domestic meat and fish waste (including fish bones, egg shells, bones, feathers, etc.)

The Composter can be collected from the Recycling Centre

# THE RECYCLING CENTRE

**What is it?** The **Recycling Centre** is an area equipped for the collection of differentiated waste from households. Waste delivery is **free of charge** and is accessible to all taxpayers of the **Municipality of Castiglione del Lago**. **How to do it?** To deliver your waste, turn up with your TARI holder health card which will be used to record the types and weight of the materials delivered. **How does the Economic Incentive work?** All OWNERS of the Municipality of Magione who take their waste to the Recycling Centre are entitled to an economic incentive, calculated on the basis of the quantity of waste delivered.

## Computerised Eco-islands

### Computerised Eco-islands



In order to facilitate the transfer of waste, three computerised Eco-islands will be installed for the delivering of **Residual Dry, Plastic, Paper/Cardboard** and **Organic Fraction**. Thanks to the Eco-islands, anyone who is in a position to dispose of an extraordinary quantity of waste will be able to use this service, which is always active, without restrictions on times or days.

#### How to deliver to the Computerised Eco-islands

Users will be able to use the Eco-islands by identifying themselves by means of a specific RFID card associated with the TARI bill payer. ## Collection Incontinence pads

### Free Nappies and Incontinence Pads collection service

Families who find themselves in difficulty, having to dispose of a considerable number of nappies and/or incontinence pads, will be able to take advantage of a **dedicated collection service, using bags**.

This service can be **activated** in the name of the TARI bill payer **at the new Eco Counter** where, in addition to filling out the activation form, you will also receive the kit of bags that must be used exclusively for the delivery of nappies and incontinence pads. The nappy collection service will be activated from 1 April 2021. For further information contact our users office (*contact details at the bottom of the page*).



## Collection of Grass Cuttings

### Grass cuttings collection service

For families that have to dispose of **asignificant quantity of cuttings, a dedicated home service is available**. All domestic users who self-certify a real need by virtue of having a garden, etc. can activate the service. Users will be given a kit of 120 66-litre biodegradable bags and the collection schedule indicating the day of collection that will take place, from April to September, on a weekly basis.

#### Attention!

Prunings instead must be taken to the recycling centres of the municipality.



## Eco Counter URP

### Eco Counter available to users

In order to offer an increasingly widespread service in the area, an **Eco Counter** (URP) will be activated at the **Municipality headquarters** in Piazza Frà Giovanni da Pian di Carpine on the following days and opening hours: **Monday from 15:00 to 17:30** and **Wednesday from 8:30 to 14:00**.

The Eco Counter will ensure the correct computerised management of waste collection equipment, the signing/transfer or termination of free loan agreements, the distribution of information material, the updating of personal data and the annual supply of plastic collection bags or any other service required by the Municipal Administration.
